TEAM / DOUBLES / SINGLES

1. The Annual Championship Tournament will be held February 25-26 and March 3-4, 2012.
2. It shall be a Handicap Tournament, one division, consisting of three events; **four** member team, doubles and singles.
3. Entry fee shall be \$23.00 per event; \$3.00 for All Events Handicap; \$5.00 for All Events Scratch. (All Events Handicap & Scratch are optional. Bowlers may enter both)
4. After the entry has been received by the Association Manager, entry fee will not be refunded.
5. Individual handicap to be used; 90% of the difference between average and 220.
6. Entrants in the Championship Tournament shall use their highest 2010-2011 USBC Year Book average.

IF NO USBC YEAR BOOK AVERAGE:

- a. Highest 21 games or more as of January 1, 2012 either as a regular member or as a substitute in a sanctioned USBC league.
- b. An entrant without a 2010 - 2011 USBC book average or 21 games as of January 1, 2012 may use a 2011 USBC sanctioned summer league average of 21 games or more
- c. An entrant without a 21 game average as of January 1, 2012 shall use her highest average for at least 15 games as of February 19, 2012 in a USBC sanctioned league.
- d. An entrant not qualifying for a, b, or c, must use a scratch average of 220.

NOTE: Entrant is responsible for average verification in using "b", or "c" above.

7. Entry deadline shall be February 13, 2012. All entries postmarked by February 14, 2012 which is the first business day following the entry closing date, will be accepted.
8. Each bowler must be a member of the Orlando USBC WBA and/or the SEMINOLE USBC WBA, the Florida USBC WBA and USBC.
9. A bowler may enter the team event more than once.
10. List names on entry blank in order they are to bowl. No position changes will be allowed in the line-up.
11. Scores from the first team event bowled shall be used toward your All Events Score.
12. A bowler who participates in doubles and singles must participate in both events and can only bowl ONCE in each event. Bowlers may bowl doubles and singles without bowling in the team event.
13. **FOUR WOMAN TEAM EVENT:** not more than two players on the same team may place more than once in the prize list in the team position standings. Handicap and Scratch awards will be given to 1st Place in Team, Doubles, Singles and All Events.
 - A. If there is a tie for First Place – Co-champions will be declared.
14. Team Captains shall check in at the Tournament Office 30 minutes prior to their scheduled time of bowling. All Substitutes must take the place in the line-up of the person for whom she is replacing.
15. A bowler shall bowl her doubles event first. If one bowler is late for the doubles event, the bowler present may bowl her singles event first. If her partner has not arrived by the time the singles event is completed and a substitute cannot be found, she will be permitted to bowl in the doubles event in order to qualify for the All Events.
16. Entries will be scheduled in the order that they are received. Three sets of doubles will be scheduled to a pair of lanes. Adjustments to lane assignments will be made if necessary.
17. Seven minutes of practice will be given for the Doubles Event; Ten minutes of practice for the Team Event.
18. At no time during tournament play shall anyone be allowed in the bowler's circle except participating bowlers and tournament officials.
19. There shall be no practice bowling on the lanes the day of the tournament.
20. Any infraction of these rules will lead to automatic disqualification of any team or individual.
21. The President, with the approval of the Board of Directors of the Orlando USBC WBA, shall be empowered to relocate the Annual Championship Tournament to another center if, in their opinion, it becomes advisable.
22. There will be no pacers.
23. Rule 319-C will apply. Bowlers listed in a known undeclared Sports League may have an average adjustment using the scale listed in the USBC playing rules. Tournament director has the right to re-rate any bowler with just cause.
24. Any rules not listed for this tournament will be covered by USBC rules.
